The Training of Professional Ensuring the Grasp of the Most Recent Trends: The 2023 Seminar on Filing of Objections and Enforcement Cases Held and Organized by AEA

To enhance the professionalism of Administrative Enforcement Officers, the Administrative Enforcement Agency, AEA (MOJ) held and organized the "Seminar on Filing of Objections and Enforcement Cases" on December 13, chaired by Director-General Huang, Yu-Yuan, in which Deputy Director-General Yeh, Chih-Chiang, the Chief Secretary, the heads of relevant divisions of AEA and the Chief Enforcement Officers of all branches of AEA participated to learn about the keynote speeches on newly-promulgated acts and cases of enforcement.

On the date of the Seminar, a new version of the "Administrative Execution Code (Parts about the compulsory execution on obligatory payment under public law)" was released, whose cover featured the watercolor painting of the architectural appearance of the AEA. It was one of the works of the collection of legal compliance series, and its electronic version was also published on AEA's official site at https://www.tpk.moj.gov.tw, which was available for both AEA staff and colleagues, other government personnel and the general public.

In the morning seminar on filing of objections, Judge Chen, Yan-lin of the Department of Administrative Litigation and Discipline of the Judicial Yuan delivered a keynote speech on the key notes of the amended Administrative Litigation Act promulgated on August 15, 2023 and the impact of the new administrative litigation system on

administrative enforcement. Judge Chen stated the fact in which the Judicial Yuan had established a new litigation framework with a solid first-instance system for administrative litigation, as well as the contexts of new laws related to matters including remote hearings, circuit courts, mandatory legal representation, and the prevention of abuse of litigation procedures. Judge Chen also cited two successful mediation cases in Germany, respectively known as the "Gas Station Business Operation Case" and the "Road Development Fees Case," and compared them with Taiwan's administrative litigation settlement cases to present an introduction to the statutory requirements, procedural requirements and related processes of Taiwan's mediation system for administrative litigation.

The afternoon seminar was chaired by four Enforcement Officers, respectively, Chen, Chin-Hui of the Shilin Branch, Li, Hsu-Heng of the Taipei Branch, Huang, Ling-Ya of the New Taipei Branch, and Hung, Kuo-Tang of the Chiayi Branch, who respectively gave the keynote speech on the methods of identifying overseas shell companies, identification of the person in-charge with substantive influence when handling the cases of seizure, comparison of suspicious cash flow and accounting information to discover property able to be enforced to request the court to allow further seizure, as well as sharing relevant experiences.

At the end of the Seminar, Huang, the Division Head of the Legal Affairs Division, introduced the content of the Examination Yuan's high-rank civil servant advanced training programs, and shared the viewpoints on the feasibility of the application of domestic and foreign professional courses in public service affairs with the aim of enabling colleagues and staff to expand their visions and understand the latest trends worldwide.

Director General Huang, at the end of the Seminar, encouraged all the attending colleagues and staff to keep abreast of the latest policy trends in digital governance and

technological development, seize opportunities for experience in different fields, be fully open-minded when facing challenges, as well as demonstrating professionalism and adequate self-confidence.
